The service provider will conduct an initial screening with the applicant in order to ascertain whether the applicant is eligible and suitable for enrolling YETP.
- 5. Trainees may, after the initial screening, participate in the workplace attachment training or receive on-the-job training. Eligible trainees may also enrol on training courses of the Employees Retraining Board and YETP on the recommendation of career advisors.
- 6. The Programme Office may contact applicants to verify information submitted or request further information.
- 7. YETP may conduct photo and video shooting during our activities for promotional and publicity purposes.
